

## Terms and Conditions

### Safripol Let's Plastic Responsibly Toy Campaign Competition

By entering the Safripol Let's Plastic Responsibly Toy Competition, you automatically agree to the following Terms and Conditions set out below.

This competition is open to all South African residents over the age of eighteen (18) years (any persons under the age of eighteen (18) must have their parent/guardian's permission before entering).
